

























We provide families with seriously ill or injured children a home-away-from-home and a caring community of support when they need it most.

In 2023, RMHC-UM served 5,770 families across our five Minnesota locations.

We provided 21,753 nights of lodging to families, saving them more than \$6.8 million in out-of-pocket expenses for hotel stays and meals, as well as basic daily supplies, and transportation costs.

Our Family Service programs and activities provide social and emotional support to family members of all ages, and include fun diversions as well as activities that address health and wellness needs.

Families tell us that complimentary meals and snacks are the most important service we provide. Our robust meal program provides three nutritious meals a day, as well as healthy snacks and a grab and go refrigerator available 24/7.
